Henry is a former elected corporate officer for General Dynamics Corporation (a Fortune 100 company), where he served as its corporate vice president of human resources and shared services. Currently, he serves as a senior fellow for the HR Policy Association, a Washington, DC-based organization that represents chief human resource officers for the world's largest corporations. He also serves as an arbitrator for the American Arbitration Association where he arbitrates complex business transactions in the multiemployer area.

In his role at General Dynamics, he oversaw the corporation's shared services function, which annually processed and accounted for approximately \$10 billion in expenditures, including payroll (payroll tax) and other related expenses.



In addition to his significant management experience, he also has significant experience in asset management and financial oversight. In 2016, President Obama appointed Henry to the Advisory Committee for the Pension Benefit Guaranty Corporation (PBGC). The PBGC Advisory Committee reports to the Director of the PBGC and responds to strategic initiatives requested by the PBGC's Board of Directors, who serve as the U.S. Secretaries of Labor, Treasury, and Commerce. In 2019, President Trump appointed him to serve as Chair of the PBGC Advisory Committee, a position he continued to hold during the Biden Administration until his term expired in February 2022. The PBGC oversees an investment portfolio of approximately \$125 billion in defined benefit pension assets. From 2012 to 2021, Henry served as trustee and co-chair of the IAM National Pension Fund (\$12 billion in AUM) and the IAM National 401(k) Plan (\$600 million in AUM). Henry currently serves as a trustee for both the America Bar Association Retirement Fund (which manages retirement programs for small and midsize law firms (\$6 billion in AUM)) and Concordia Plan Services (which manages retirement, life, and disability programs for employees of the Lutheran Church, Missouri Synod (\$6 billion in AUM)).

Since 2005, he has been an adjunct professor of law at Georgetown University Law Center (D.C.), where he lectures on corporate mergers and acquisitions, including employee benefits, executive compensation, and other benefit matters, as well as employee and labor relations. In 2015, Henry received the prestigious Charles Fahy Award for Distinguished Adjunct Professor. In 2019, he joined the adjunct law faculty of Washington University in St. Louis, where he teaches an advance tax class in WashU's graduate legal program.

Prior to joining General Dynamics, Henry was a partner at the law firm of Jenner & Block in Chicago, where he specialized in M&A and employee benefit matters. Prior to Jenner & Block, he spent nearly a decade as a consultant with William M. Mercer, Inc., a worldwide consultancy.
